I-20 REQUEST FORM

Form I-20 - Certificate of Eligibility for Nonimmigrant Student Status (F-1)

Why this form

The Form I-20 is a U.S. Department of Homeland Security (DHS) document issued by Nobel University's Designated School Official (DSO) under the Student and Exchange Visitor Program (SEVP). It allows a prospective international student to apply for an F-1 visa at a U.S. consulate, request a change of nonimmigrant status, or transfer a SEVIS record from another SEVP-certified school. Nobel issues the Form I-20 only after admission, proof of financial support, and full submission of this request (allow 3-5 business days).
